## MONDAY - MARCH 2, 2020

The Board of Education, District I-080 met in regular session at the Geary High School Library, 300 S. Blaine, on March 2nd, 2020 at 6:00 p.m. There being a quorum present, the meeting was called to order by Board President, Andy Smith.

The Geary Board of Education has complied with the Open Public Meeting Law.

The following members were present: Jason Bernhardt, Crystal Briscoe, Randall Base, Andy Smith and Scott Hicks. Superintendent Todd Glasgow and Minutes Clerk Tammie Brack were also present.

Visitors at the meeting were: Sean Buchanan - Elementary Principal, Cecil Harrall, Greg and Kim Lewis, Devon Mitchell and Connie Burcham – The Geary Star.

Andy Smith led the Pledge of Allegiance.

Hearing from the public. Cecil Harrall addressed the board referencing back to the last board meeting regarding the baseball field and adding a mound to the field. He wanted to remind the board, little league plays on that field also during the summer. The mound is set at a different footage for the little league than it is for the JH/HS. If a temporary permanent mound is put in and they cannot move that rubber, it makes it difficult to for the little league kids to play as well. The little league is the developing kids that are coming up in JH/HS ball. He would like them to take into consideration that when the mound if approved is put in.

Presentations: Baby Bison Ranch Board Report as presented in the Board Packet. Month of February 2019 - CHILDREN ENROLLED: 8; AVERAGE DAILY ATTENDANCE: 4-7; STAFF HAPPENINGS/STAFF CHANGES: Gretchen Melvin is the Director of Baby Bison & master teacher. Alexis Sealy is working as a classroom helper. The staff at Baby Bison continues their education throughout the school year. We have currently completed First Aid/CPR/AED. Directors are required to complete 30 annual clock hours. Master Teachers have to complete 20 hours annually. Gretchen Melvin has completed 30 annual hours as director, and also 20 hours as master

teacher. Alexis Sealy has completed 20 hours of early childhood education to be a master teacher as needed for Baby Bison. Mr. Glasgow stated he has made contact with Head Start.

Mr. Glasgow gave the board a recent report on the Corona Virus sent from the State Department.

Mr. Glasgow said we have already used the disinfectant machine we bought last year twice at the schools. We have already ordered another one but with the new virus, it may take a while to get it. We wanted one at each site.

Board Member Comments. Several community members and some teachers addressed Jason Bernhardt after the last meeting for not being in support of the Hamish brewer book for the staff. He wanted to clarify he was not against the purchase. He is completely in favor of any item that will help our teachers, which in turn will help our students. The reason he voted against the purchase order for those books was the fund being utilized for purchasing the books was out of general fund, and unless the books are curriculum and remain property of the school that is an illegal expendature. That is the only reason he voted against the expense. According to article 10 section, 15 of the Oklahoma constitution, the district cannot make gifts with public funds. There are different funds that can be used for purchasing the books.

Andy Smith stated, "We are doing some follow up on managing professional development purchases in the future" and will put in that in our audit process.
